
AFFIDAVIT OF PHYLISS FLOWER

I, PHYLISS FLOWER, being of sound mind, and being first duly sworn upon my oath, swear and affirm that the following is true and correct to the best of my knowledge and belief.

I live at 236 Red Mesa Heights, Grand Junction, CO.

I have a male St. Pyrenees dog named "Arlo" who is not a barking problem in the neighborhood. Arlo only barks protectively at predators such as raccoons near the chicken house, or when provoked by what he perceives as threatening or unusual activity from people, neighboring dogs or vehicles. Threatening or unusual activity comes regularly from our neighbors at 232 Red Mesa Heights. This has always been the case since they moved there in October 2014. Many different people and dogs live there, coming and going at all hours. People and dogs live in the garage, and their dogs are locked up there all day. When they are let out loose, they often run along our fence and provoke Arlo to bark. People live in their 5th wheel in the back yard, and an unknown number of people and dogs live in the main house. We are always seeing new dogs and people. They often walk with at least 3 dogs at a time and go past our front yard, headed north, and trespassing onto Gary and Sandy Parkerson's property at 238 Red Mesa Heights despite the fact they have been repeatedly informed that the Parkersons don't want people trespassing on their property. This behavior provokes Arlo. He distrusts anyone from that residence and does not like them. So he sometimes barks protectively at them. They also drive their vehicles up and down the street and into their back driveway late at night with loud music playing. We often hear yelling and screaming coming from both the house and yard at 232 Red Mesa Heights. When they let their dogs out loose in their unfenced front yard their dogs always bark. The people and dogs at 232 Red Mesa Heights are the ones who have always been the source of noise in our once quiet neighborhood.

Case in point is, Arlo does not bark at our other neighbors or their dogs or their vehicles or the comings and goings right past our property several times a day. Arlo does not bark at the Coopers or their dog Duke. Arlo likes them. Arlo does not bark at Bob Power or his vehicles. Arlo likes him. Arlo does not bark at our more distant neighbors from Canary Lane who walk their dog down our street. He does not bark at neighbors who live farther down Red Mesa Heights who take walks down our street and past our house. Arlo perceives all those people as friendly and nonthreatening. Arlo know the difference between friendly and unfriendly people.

Sharon Hill (aka Romero) and her sons, especially her son, Jack Redd, are very vindictive and hostile people towards us. As far as we can see, nothing has been done regarding law enforcement of their transgressions with their dogs running rampant in the neighborhood for over a year, regularly harassing our chickens and finally killing one (that we know of). The case went to the DA's office in July of 2015, and nothing has been heard since. I absolutely believe that the complaint from 232 Red Mesa Heights about our dog barking is
