**AFFIDAVIT OF SETH DODD-FLOWER**

I, SETH DODD-FLOWER, being of sound mind, and being first duly sworn upon my oath, swear and affirm that the following is true and correct to the best of my knowledge and belief.

I currently reside at 236 Red Mesa Heights, Grand Junction, CO, and am the owner of 228 Red Mesa Heights (3 doors down the street) where I will soon reside once renovation work at that address is complete. My 9 year-old daughter also resides with me 50% of the time.


Under penalty of perjury, I swear the foregoing statements are true to the best of my knowledge and belief.

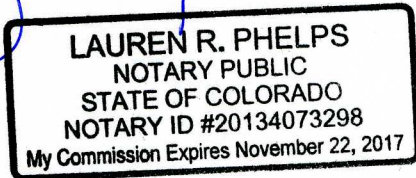
